Marketing

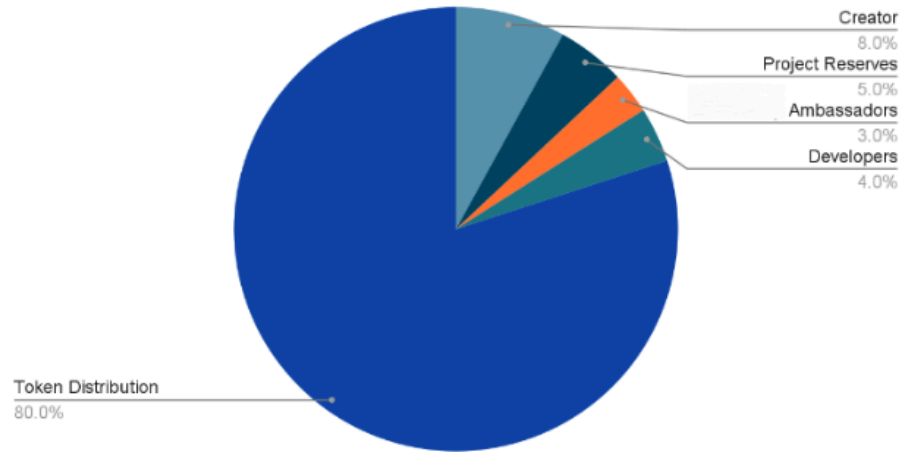
Investments in marketing will focus on raising awareness of TT, attracting new users, and establishing partnerships within the adult entertainment industry.
